1. 前言

~ <<全国校际模范[声]歌唱比赛>>是由东烽音乐主办,雪隆李氏亲会联办的赛事,目的是提供一个平台让全国的在籍学生可以互相交流.

~ 整个比赛以个人姿态及形式参加,并将以分为面试活动,选拔赛,半决赛及总决赛进行.

2. 参赛条件与资格

~ 参赛者必须符合以下条件才能参赛:

a) 参赛者必须为马来西亚公民;同时必须通晓华语及粤语.

b) 凡是歌唱和音乐爱好者的在籍学生均可参加.

c) 年龄: 13 岁以上. (没有和其他公司签定演艺合约)

d) 品德操行无不良记录.

~ 根据参赛者提供的资料背景,主办当局将有权修订资格,并无需事前同志参赛者.

3. 报名方式

此赛事将附上 2 项报名方式。

为什么选择亲临现场试音活动利于邮寄demo?

邮寄 demo 参赛方式是能够让外州以及不能亲临现场参与试音活动的参赛者的另一个管道。虽然这两项报名参赛方式都或得同样的评分标准，我们依然鼓励及建议大家能够亲临现场参与试音活动。因为每位参赛者皆可得到评审对于自己表现的评论与评语。我们坚信每位参赛者都必须知道自己在演唱的实力与弱点。透过试音活动大家能够直接得到评审对于自己的表现做现场的讲评；同时也可以从中得到建议，好让自己能更加进步。然而，邮寄 demo 的参赛方式将不会得到评审的评语与建议。

4. 参赛程序

- a) 参赛者必须填妥及签署参赛报名表格。
- b) 参赛者交上参赛报名表格时，必须附上以下文件：
 - ✓ 参赛者的身份证副本；
 - ✓ 参赛者的 4R 近照 1 张.(半身)
 - ✓ 18 岁以下的参赛者必须附上家长或监护人的身份证副本。
- c) 参赛表格及附属文件都必须在面试活动前交由主办当局。
~ 主办当局有权要求参赛者提供以上文件的正本，以做校对工作。

5. 比赛形式

~ 比赛共分为 4 个阶段: 面试活动, 选拔赛, 半决赛及总决赛.

a) 面试活动

- 参赛者将以清唱方式演唱自选歌曲的副歌部分.
- 参赛歌曲语言将不受限制.
- 评审将有权要求参赛者演唱另选歌曲.
- 面试活动将在以下地点与时间进行:
 - ✓ 日期: 2009 年 8 月 22 日 (星期六) 开始
 - ✓ 地点: 吉隆坡 (东烽音乐公司)

b) 选拔赛

- 选拔赛的入围者将在面试活动后, 由主办当局另行通知. 同时将透过电联与电邮的方式联络成功进入选拔赛的参赛者.
- 参赛者必须在塞前的 2 个星期把曲目及其 minus 1(伴唱音乐) 交由主办当局, 此外参赛者也须携带自选曲的 CD/VCD/DVD 前往会场当后备之用.
- 参赛者必须在指定的日期, 时间与地点参赛.
- 成绩将在每轮选拔赛结束时揭晓, 并公佈进入下一回合的参赛者名单.
- 经过评选, 在选拔赛表现优秀者将获选进入半决赛.
- ~ 主办当局将有权取消缺席参赛者的参赛资格, 并有权另选人选填补空缺.

c) 半决赛

- 成功进入半决赛参赛者必须在指定的日期, 时间与地点参赛.
- 参赛者必须在塞前的 2 个星期把曲目及其 minus 1(伴唱音乐) 交由主办当局, 此外参赛者也须携带自选曲的 CD/VCD/DVD 前往会场当后备之用.
- 成绩将在每轮选拔赛结束时揭晓, 并公佈进入下一回合的参赛者名单.
- 经过评选, 在选拔赛表现优秀者将获选进入总决赛.
- ~ 主办当局将有权取消缺席参赛者的参赛资格, 并有权另选人选填补空缺.

d) 决赛

- 成功进入总决赛的参赛者, 务必在指定的日期, 时间与地点参赛; 同时总决赛入围者都必须能够出席总决赛之前由主办当局所筹备的一切赛前活动.
- 所有的决赛参赛者都必须遵守由主办当局所定下的一切规则; 犯规者, 主办当局将有权除掉起参赛者的参赛资格.

6. 参赛协议

a) 参赛者须明白及同意主办当局有权:

- 要求参赛者出示身份证及其他相关证件.
- 取消参赛者的参赛资格及无须作出任何解释.
- 修改或取消面试活动, 选拔赛, 半决赛及总决赛的日期
- 取代于其他同等价值的奖金奖品.

b) 参赛者同意:

- 参赛者同意主办当局不必退还所有呈交于此比赛用途的所有资料, 文件及 CD.
- 参赛者必须自备参赛所需道具, 服装与化妆.
- 参赛者自付于赛事期间的任何费用. (交通费, 住宿, 等等...)
- 主办当局将无须负责, 参赛者在比赛期间的任何损失, 包括伤亡在内.
- 参赛者必须服从及尊重主办单位几评审团在所有赛事当中的决定.

1. Introduction

~ "Paragon of All Stars" is a competition organized by Vertex Music and Lee Association of Selangor as the Liaison Office to provide a platform for interactivities among educational institution in Malaysia.

~ The Contest shall be open only to individual applications, which know as Contestant. The contestant required to undergo 4 rounds of competitions: auditions, heats round, semi-finals and grand finals.

2. Entry Requirement

a) The Contestant must be a citizen of Malaysia. The Contestant must be able to understand both Chinese and Cantonese.

b) The Contestant must be aged above 13 years old. (Not bound to any form of contract with company in entertainment industry)

c) The Contestant must no adverse record of moral conduct.

~ The organizer reserves the right to amend and change any entry requirements without a prior notice to the Contestant.

3. Registration

There are 2 ways to register for this competition.

f) Expected audition date **22nd August 2009** in Kuala Lumpur

➤ All entries must reach us **before 8th August 2009**.

➤ Registration will only be proceed upon receipt of the registration fees.

4. Entry Procedures

- a) The Contestant must complete and sign the registration form.
- b) The Contestant must submit the registration form together with the following documents:
 - ~ Photocopies of The Contestant's Identification Card;
 - ~ 1 recent 4R-size photograph of The Contestant. (One half-length)
- c) For contestants below 18 years of age, they are required to obtain the parent's or guardian's consent. A photocopy of the parent/guardian's IC is a necessity.
- d) The Contestant has to submit the registration form attached by the required document before the competition.
 - ~ The organizer reserves the right to request original documents from The Contestant for verification purpose.

Why choose walk in audition instead of mailing the entry

Mailing of the entry is to facilitate participants who are based outside KL and are facing difficulty in coming to the audition. Although both the registration process receives the same treatment and judgments we would encourage participants to be present for the audition. A panel of judges will be appointed during the audition day and each participant will receive feedbacks from the judges of their performance. We strongly believe each participant should know their strength and weakness in their singing skills hence knowing their area to improve. Entries mail will also be judged by the same panel but will not receive feedbacks from the judges.

5. Competition Flows

a) Auditions

- The Contestant will only need to sing approximately 1 minute of the chosen song. The contestants can opt to sing from the middle of the song.
- That is no limitation on the song language chosen.
- Depending on the need, the judges may ask the contestants to perform another song.
- The audition will be held on the following details:
 - ✓ Date: 22nd August 2009 start
 - ✓ Venue: Kuala Lumpur (Vertex Music Company)
 - ✓ ~ The organizer will make an audition appointment with the contestants upon the confirmation of their participation.

b) Heats Round

- After the audition, the organizer will call and post the selected Contestant name list on Vertex Music website for the next round.
- The contestant must be ready to provide the own CD or VCD with MINUS-1 to the organizer at any time.
- The Contestant is obligated to attend the heats round at the location and time determined by the organizer.
- ~ The organizer reserves the right to replace any Contestant who fails to attend the heats round.

c) Semi-Finals

- The Contestant is obligated to attend the semi-finals at the location and time determined by the organizer.
- The contestant must be ready to provide the own CD or VCD with MINUS-1 to the organizer at any time.
- The organizer reserves the right to replace any Contestant who fails to attend the Semi-Final.

d) Final

- The Contestant is obligated to attend the grand final at the location and time determined by the organizer.
- The Contestant must be able to attend all the activities before the Grand Final.
- The contestant must abide to all rules and regulation set by the organizer.
- The organizer reserves the right to summarily disqualify and/ or replace the Contestant.

6. Competition Agreement

- a) The Contestant understands and agrees that the Organizer reserves the right:
 - To request the Contestant presents his/her identification card, and other relevant documents to prove the identity.
 - To disqualify the eligibility of any Contestant without any explanation.
 - To amend or cancel the dates of Auditions, Heats round, Semi-Finals and Grand Finals.
 - Replace the prizes with equivalent value item(s).

b) The Contestant agrees:

- The Organizer shall not return all the photographs and the documents that submitted by the Contestant.
- The Contestant shall bear their own transportation and accommodation fees.
- The Contestant required preparing their own props, costumes and make-up.
- The Organizer shall not be responsible for any loss including injury or death incurred to the Contestant during the competition.
- Usage of all recordings and pictures for promotional use
- All judges' decision is final.
